



## **RULES OF CONDUCT ON THE BECK RANCH**

- 1) Certain areas of the Beck Ranch are blocked off from access during the Clay Shoot. No one but authorized personnel or the Beck family is allowed in those blocked off areas.
- 2) No one may bring bottles or cans of alcoholic beverages onto the Beck Ranch; the only alcoholic beverages consumed on the Beck Ranch should be those beverages provided by the Rotary Clay Shoot bar on the Beck Ranch.
- 3) Children (defined as those persons under age 18 years of age) may come onto the Beck Ranch only if accompanied AT ALL TIMES by their parents or a responsible adult.
- 4) Children shall only walk and not be running around while on the Beck Ranch.
- 5) Any child riding on an ATV must be riding the ATV with a responsible adult.
- 6) All ATVs shall not be driven on the Beck Ranch fast and shall not be driven as part of any racing or joyriding.
- 7) All used drink and food containers must be placed in the trash receptacles provided by the Beck Ranch.
- 8) The sellers/servers of alcoholic beverages at the Clay Shoot have the absolute right to refuse service of alcoholic beverages to anyone, especially if a person is believed to be intoxicated or believed to have had too many alcoholic beverages.

VICTORIA ROTARY PERSONNEL AND THE BECK FAMILY RESERVE THE ABSOLUTE RIGHT TO ASK ANYONE TO LEAVE THE BECK RANCH WHO VIOLATES ANY OF THESE RULES, OR IF THEY BELIEVE, IN THEIR SOLE DISCRETION, THAT ANYONE WILL VIOLATE ANY OF THESE RULES.

The undersigned agrees that access to the Clay Shoot on the Beck Ranch is conditioned on compliance with all of the above rules.
